World body asks for clarity

New Delhi: President of United World Wrestling (UWW) Nenad Lalovic, "oncerned" with the turmoil in the Indian wrestling fraternity, has demanded clarity on who is running the sport in the country. In its response, the Wrestling Federation of India (WPI) has complained of "government interference" in their matters.
